Limitations on registration plants:

The plant is intended to be worth the value of the registration fee by itself. For the first 25 registrants, he or she may choose their plant from a list, while supplies last. Each plant will have been potted for 3 months, so they're established for the winter, with color pictures. For registrant 25 and above, a selection of recently registered daylilies will be available by Dianna Gossard, Kirsten Hatfield, and Bobby Scott.

Quantities are limited. After each registrant selects, going in the order that they registered, the remaining quantity will be updated, and the updated list will be emailed to the next registrant that posted their Registration and paid the fee. Only the Registrar's email or address will be used for registration.

The registrant, in person, must be present to receive the plant; friends cannot pick up registration plants for friends who are not at the Convention.
